Acceptable Use Policy

Arena One, LLC and its affiliates ("Arena One") has created this Acceptable Use Policy ("AUP") in an effort to promote responsible use of its networks, systems, website, products, services and solutions (the "Services") by our clients and other end users(hereinafter "Users"). If you have a service agreement with Arena One and/or one of its affiliates ("Service Agreement"), this AUP is to be used in conjunction with those terms. Due to the fact that Arena One offers many different specialized services, additional product terms and service specific terms may also apply. Any such terms will be available as part of your Service Agreement with Arena One and will govern those services. If there is a conflict between your Service Agreement and this AUP as to governing law or warranties and disclaimers, your Service Agreement will govern. By using or accessing the Services, all Users agree to be bound by and adhere to the terms of this AUP.

In addition to any other agreements between Users and Arena One, this AUP explains the policies that govern Users access to and use of the Services, including the actions that Arena One may take, within our sole discretion, for any use that we deem unacceptable. Arena One reserves the right to modify this AUP in its discretion, at any time and any such modification shall be effective upon posting to this website. Any use of the Services after such modification shall constitute an acceptance of the modifications made.

Prohibited Conduct

Services may only be accessed and used for lawful purposes. All Users are responsible for any transmission it sends, receives, posts, accesses, or stores using the Services, including the content of any communication, with or without the Users consent. Additionally, transmitting, distributing or storing any material that violates any federal or state laws or regulations, or any industry or community standard are strictly prohibited. Accordingly, Users may not:

- Attempt to use or gain unauthorized access to data, accounts, hosts, servers, systems or networks of others, nor relay communications through any third-party servers without the owner's authorization.
- Probe, scan or test the vulnerability of our system or the Network without Arena One's prior written consent.
- Interfere with the Arena One Services or another's use of the Services in any way.
- Infringe the intellectual property rights or other proprietary rights including, without limitation material protected by copyright, trademark, patent, trade secret or other intellectual property right.
- Violate the rules, regulations or policies that apply to any third-party network, server, or computer database that is accessed by any User.
- Disseminate or post material that is unlawful, libelous, defamatory, obscene, indecent, explicit, lewd, harassing, threatening, harmful, invasion of privacy or publicity rights, abusive, inflammatory or otherwise objectionable.

- Offer or disseminate fraudulent goods, services, schemes, or promotions (e.g.: pyramid schemes)
- Disseminate or post harmful content, including, without limitation, Trojan horses, worms, time bombs, zombies, cancelbots or any other computer or other programming routine that may damage, interfere with, secretly intercept or seize any system, program, data, or personal information.
- Email spamming (or mailbombing) is strictly prohibited. Accordingly, Users may not transmit (a) unsolicited advertisements, commercial e-mail messages or promotional messages, (b) unsolicited informational announcements of any kind; (c) chain mail, (d) numerous copies of the same or substantially similar messages, (e) messages which contain no substantive content, (f) empty messages, or (g) large messages or files that disrupt a server, account, newsgroup or chat service.
- Use the Services to violate email, telemarketing or telecommunications laws, rules or
 regulations, or in a manner that has a negative effect on our network or service delivery
 (including, without limitation, by the use of mass dial or pre-recorded calling applications in
 violation of law or regulation; overloading servers; violating caller-ID regulations; causing any
 portion of the Network to be blocked by other network providers; generating unresolved thirdparty complaints or complaints, which in Arena One's sole discretion, impose an unreasonable
 administrative burden on Arena One).
- Upload, post or otherwise distribute or facilitate distribution of any email that contains any
 viruses, corrupted files, or any other similar software or programs that may damage the
 Network or the operation of any other computer.
- Use any forged, false or misleading number identity, email header, invalid or non-existent domain names in email or postings or employ techniques to hide, obscure or counterfeit the source of an email or posting.
- Auto-dial or predictive-dial (sometimes referred to as "robodialing") on trunks that are not specifically designated for dialer use.
- Continuously or extensively engage in chat line or conference call participation.
- Use free conference calling or similar services that Arena One, in its sole discretion, deems to participate in traffic stimulation practices or schemes that result in excessive charges.
- Use an open telephone line for monitoring, intercom or similar service.
- Repetitively and/or continuously message or call the same destination or number if such activity could reasonably be expected to or in fact does provoke complaints.
- Make long duration calls (defined as calls to the same number in excess of four continuous or cumulative hours within a 24-hour period) and/or calls placed to specific numbers / destinations for the purpose of generating charges or fees for or with a third party.
- Use voice Services which do not consist of uninterrupted live human voice dialog by and between natural human beings.

- Restrict or inhibit any other User or any other person from using and enjoying the Services and/or the Internet.
- Engage in any of the foregoing activities by using the services of another provider or third party and channeling such activities through an account provided by Arena One, or otherwise involving the Services or any Arena One account in any way with or without another provider or third party for the purpose of facilitating the foregoing activities.

Network Security

Users may not violate the security of the Network in any way and such violations may result in criminal or civil liability. If any such violations are reported, uncovered, or suspected, Arena One may investigate and cooperate with law enforcement and all Users agree to cooperate in any such investigation.

Arena One reserves the right to take all available legal and technical steps to prevent all Prohibited Conduct and protect its Network Security, including the right, without prior notice, to monitor content and traffic patterns, perform vulnerability tests on systems residing on our IP address space, or to quarantine servers or User accounts if circumstances require. Such testing may include, but is not limited to, testing of mail and Internet servers or proxy servers for unrestricted third-party relaying. Arena One will use commercially reasonable efforts to ensure that such testing will not adversely affect the Services or compromise service performance or the security of the networks. Users may be required to correct any system vulnerability upon notification and/or suspend or terminate operations of a known compromised system.

Content

"Content" means any communication or information that may be generated, stored, cached, copied, published, transmitted or otherwise used by or made available by any User or through any Users use of the Services, including but not limited to websites, software, data, documents, photographs, videos and messages.

Subject to the terms of any agreement with Arena One, Arena One does not claim any right or interest in User's Content and assumes no responsibility of any kind for User's Content. Custody, possession, control, and security of all of User's Content, regardless of its nature, are User's sole responsibility, and User is liable in all aspect for its Content. Users may not use the Services to download, publish, distribute, or otherwise copy or use any Content in any manner protected by copyright law. Users use of the Services is not edited, censored or otherwise controlled by Arena One, however Arena One does reserve the right to remove content, disable sites, or suspend or terminate any Service if Arena One determines, in its sole discretion, that Content or User practices are harmful, offensive, or otherwise in violation of law, applicable Service terms or this AUP.

Violations, Investigation Enforcement

All Users must adhere to the terms of this AUP. Arena One shall have the right, but is not obligated to enforce this AUP through all legal means. Any User who violates this AUP may be subject to warning, followed by suspension and/or termination of the Service if the violation does not cease. Arena One may immediately suspend or terminate the affected Service with or without notice if Arena One reasonably

determines (in Arena One's sole discretion) that a violation of the AUP has occurred, and/or such violation exposes Arena One to civil or criminal liability, including any Users whom Arena One becomes aware has engaged in such activity multiple times. Arena One further reserves the right to conduct investigations into fraud, or other violations of this AUP, or other laws or regulations, and to cooperate with legal authorities and third parties in the investigation of alleged wrongdoing, including disclosing the identity of the user Arena One deems responsible for the wrongdoing.

Arena One may also access and disclose any information (including transactional information) related to any Users access and use of the Services for any lawful reason, including but not limited to: (1) responding to emergencies; (2) complying with the law (subpoena compliance); (3) protecting Arena One's rights or property and those of our customers; or (4) protecting users of those services and other providers from fraudulent, abusive, or unlawful use of or subscription to, such services. INDIRECT OR ATTEMPTED BREACHES OF THIS AUP, AND ACTUAL OR ATTEMPTED BREACHES BY A THIRD PARTY ON BEHALF OF ANY USER MAY BE CONSIDERED TO BE BREACHES OF THIS AUP BY SUCH USERS.

Users are responsible for ensuring that its conduct is at all times in compliance with all applicable laws, rules and regulations.

Indemnification

Users agree to indemnify, defend and hold harmless Arena One, its officers, directors, employees, agents, affiliates, shareholders, direct and indirect subsidiaries, licensors, and suppliers from and against all claims, liabilities, losses, expenses, damages and costs, including reasonable attorneys' fees, that arise from: (1) any violation of this AUP by Users; (2) any violation of any rights of a third party by Users; (3) any violation of applicable law; (4) information or content that User submits, posts, transmits or makes available through the Network; or (5) Users use of the Network.
